## **Academic and scientific activities**

He is Full Professor of Administrative Law at the Law Faculty of “A. Avogadro” University in Alessandria

From 1992 to 1999, he served as researcher in Administrative Law at the Public University of Milan.

From 1996 to 2001 he served as Professor of Administrative Law at “L. Bocconi” University in Milan.

From 1999 onwards, he has been serving as Professor of Administrative Law, Environmental Law and Public Law of Economics at the Law Faculty of “A. Avogadro” University in Alessandria.

From 2004 to 2011, he served as Director of the Master in “Law and Economics of Environmental Goods” at the Law Faculty of “A. Avogadro” University in Alessandria.

Professor Bruti Liberati is a faculty member for the PhD course in “Local self-governments, public services and rights of citizenship” (DRASD) at the “A. Avogadro” University of Alessandria.

He held courses at the “Guardia di Finanza” (Italian Finance Police) Academy in Bergamo and various other national (e.g. Ministry of Economics, Energy and Gas Authority) and local public administrations (e.g. Province of Alessandria) and lessons at PhD courses in other universities (e.g. University of Milan, “L. Bocconi” University and University of Pavia).

He is Director of the “Journal of Markets Regulation” (“Rivista della Regolazione dei Mercati”), edited by Giappichelli Editore.
